

## Privacy Policy

Protecting your privacy is important to us.

The North Somerset Agricultural Society (the NSAS) is strongly committed to protecting your privacy and complying with your choices. Both personal and non-personal information collected is safeguarded. Your information will not be shared, rented or sold to any third party.

### 1. Notice

We will clearly inform you when information that personally identifies you ("personal information") is asked for and you will have the choice to provide it or not. Generally, this information is requested when you purchase tickets to the North Somerset Show, apply for a trade stand or catering pitch or enter to compete.

### 2. Usage

We use your personal information for the following purposes:

- To provide you information that will allow you to use the NSAS website
- To send documentation relevant to your purchase or entry
- To automatically customise your documents with your information
- To alert you of other events run by the NSAS

### 3. Consent

When you provide your personal information, you consent that it can be used for the above purposes and that the NSAS is an authorised holder of such information. If you choose not to register or provide personal information, you can still use our website but you will not be able to receive additional services. You may contact us to unsubscribe from further communications at the address provided at the bottom of this page.

### 4. Access to Your Information

You are entitled to review the personal information you have provided us and ensure that it is accurate and current at all times. To review or update this information simply request that we send you this information.

### 5. Security of Information

The NSAS is committed to protecting your information and ensuring that your choices are honoured. We have taken security measures to protect your data from loss, misuse, unauthorised access, disclosure, alteration, or destruction. All sensitive data is stored behind firewalls on secure servers with restricted employee access.

We guarantee that all e-commerce transactions follow the latest security measures. Secure Sockets Layer (SSL) technology is employed when you place online orders or transmit sensitive information. SSL is one of the safest methods of passing information over the Internet.

### 6. What We Do With the Information You Share

Your information is never shared outside the company without your permission. Inside the company, data is stored on secure servers with restricted user access.

When you apply to or purchase from the NSAS you are asked to provide your contact information, including a valid email address. We use this information to send you updates about the NSAS, order confirmations and information about our events. When you order from us, we ask for your credit/debit card number and billing address. We use this information only to bill you for the product(s) you ordered at that time.

We may on occasion require the help of other companies to provide limited services on our behalf, such as delivery, customer support and processing event registrations. We will only provide such companies with the information required for them to perform these services; these service providers are bound by strict privacy policies and are prohibited from using your information for any other purpose.

In very rare instances the NSAS may disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on the NSAS or the site; (b) protect and defend the rights or property of the NSAS; and (c) act in urgent circumstances to protect the personal safety of users of the NSAS, its websites, or the public.

## 7. How to Opt-Out

We provide users with the opportunity to opt-out from receiving updates on our events, newsletters and other communications from us. You can opt-out by contacting us at the address at the bottom of this page.

## 8. Does THE NSAS's Privacy Policy Apply to Linked Websites?

Our Privacy Policy applies solely to information collected on our website.

The Site contains links to web sites of third parties. The NSAS is not responsible for the actions of these third parties, including their privacy practices and any content posted on their web sites. We encourage you to review their privacy policies to learn more about what, why and how they collect and use personal information. However, as is true with all online actions, it is possible that third parties may unlawfully intercept transmissions of personal information.

## 9. Changes to This Policy

If we make changes to our Privacy Policy, we will post these changes here so that you are always aware of what information we collect, how we use it and under what circumstances, if any, we disclose it. If at any point we decide to use your information in a manner different from that stated at the time it was collected, we will notify you by email.

## 10. Enforcement of Policy

If for some reason you believe the NSAS has not adhered to these principles, please notify us and we will do our best to promptly make corrections.
